Foundation's Board of Trustees

The Board of Trustees of the Pro Missa Tridentina Foundation has three members. One natural person out of the three is the chairman of the board of trustees and represents legally and completely the Pro Missa Tridentina Foundation. The Board of Trustees was elected for an indefinite period.

Managing and protecting the assets of the foundation

- 1. The assets of the Foundation shall be managed and used in accordance with its purpose in the manner laid down in the deed of foundation.
- 2. The founder and the affiliate shall not withdraw or dispose of the assets assigned to the foundation, any other provision of the charter is null and void. This provision shall also apply to the successor in title of the founder and the affiliate/s/.

The beneficiary

The foundation's assets are linked to the achievement of the Foundation's targets and service/s/ from these assets can be given to the person(s) who are assigned in the deed of foundation or in the absence of any regulations, to those who are granted by the authorized organization of the foundation as a supervisor.

The limitations of the Foundation's activities

- 1. The Foundation does not engage in direct economic activity.
- 2. The Foundation is authorized and may carry out an economic activity directly linked to the achievement of the foundation's targets..
- 3. The Foundation may not be a member with unlimited liability to another legal entity and may not establish a foundation and it can't join a foundation.

Goals according to the Basic Charter

Main activity:

- 1. Establishing scholarships for young boys and men, seminars, monks, brothers and sisters church professions' learning, preparing activities at homeland/abroad;
- 2. Establishing scholarships for the theological activities, learning, studying of laymen to support them in the preparation of their projects;
 - Supporting the celebrations of traditional Roman Catholic Masses,
 - Support for traditional Roman Catholic priesthood training,
 - Supporting the presentation of Rituale Romanum, Pontificale Romanum + celebration of the traditional Masses and liturgical acts reinforced by Holy Pope V Pius [Quo Primum] and the Trident Synod.
 - Supporting Seminars and / or Priests in learning for the purposes set out in the previous paragraphs,
 - Support for the traditional Roman Catholic faith and practice based on Catechismus Romanus,
 - Supporting traditional Roman Catholic communities,
 - Arranging and maintaining faith or religious education, especially for the youth plus meetings, assemblies,
 - Saving, restoring Latin missals (up to 1962), Breviarium Romanums and on-demand books , bilingualism,
 - Searching for theological books, catechisms restoring them on demand making reprinted editions, written and published before 1965,
 - Latin, Greek language teaching, education, training courses,
 - Organizing pilgrimages, organizing and sponsoring training courses,
 - Publishing, editing, and maintaining audio + internet + video or printed media materials about cultural and religious activities. Enabling to publish traditional Catholic written contents,
 - Support for Large Families, Care for the Elderly, Support for Care,
 - Maintenance and operation of protected environment for victims of violence and disadvantaged people, protected houses,
 - Charity Support for Peripheral People through tenders,
 - · Promoting the social and religious life of disadvantaged groups,
 - Organizing and supporting leisure activities,; maintaining leisure center/s/,
 - Starting, maintaining and operating a normal day-to-day educational and boarding school and supporting its activities,
 - Providing information and other assistance to Catholic (Christian) peoples and families, primary Europe, fleeing and wishing to settle in Hungary
